Tax Return Preparation

- We will prepare your 2023 federal and state tax income tax returns based on information you provide. Services for preparation of your return do not include auditing or verification of information provided by you.
- This engagement does not include any audit or examination of your books or records. In the event your return is audited, you will be responsible for verifying the items reported.
- The law imposes penalties when taxpayers underestimate their tax liability. Should we encounter instances of unclear tax law, or of potential conflicts in the interpretation of the law, we will outline the risks and reasonable courses of action. We will ultimately adopt, on your behalf, the alternative you select.
- Our fee is based on the time required at standard billing rates plus out-of-pocket expenses. Fees charged do not include bookkeeping or audit representation. Invoices are due and payable upon presentation. We will not electronically file your tax returns until payment is received. Payment is required for the work completed, even if the outcome is not to your liking.
- Our engagement to prepare your 2023 tax returns will conclude with the delivery of the completed returns to you (if paper filing) or your signature and our subsequent submittal of your tax return (if e-filing). We will return your original records to you at the end of this engagement. We do not have influence over the IRS or State issuing of your refunds. Please store your supporting documents and copies of your tax returns in a secure place for at least seven years. You may be assessed a fee for future copy requests.
- In the event of a complaint related to the services we provide, we agree to discuss the complaint, and if necessary, take action in a good faith effort to resolve the complaint. If we make an error on your tax return, and it is discovered after the tax return has been filed, we will pay any initial penalties & interest that result from that mistake, however, we are not responsible for additional taxes that may arise from an error.
